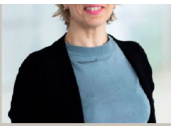
Assistance with the regulators and in court

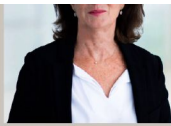

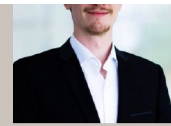
